Please find enclosed the Tournament request form for the 2012 Season

Nor Cal ASA requires that 10u, 12u & 14u "A" teams and All "B/C" Junior Olympic (JO) teams must play in one (1) Nor Cal Pre-Qualifier or a pre-approved tournament by Nor Cal JO Commissioner to advance to the Nor Cal ASA Championship Tournament. 16u & 18u "A" teams are exempt from this requirement. The Nor Cal Junior Olympic "A" Championship Tournament will be held the weekend of June 15, 16 & 17, 2012 and Nor Cal Junior Olympic "B" & "C" Championship Tournaments the weekend of June 22, 23 & 24, 2012, with both being played at Twin Creeks in Sunnyvale.

The JO "A" Pre-Qualifying Tournaments can be scheduled from January 1st weekend to the June 8th weekend. The JO "B" or "C" Pre-Qualifying Tournaments can be scheduled from May 25th weekend to June 16th weekend. The sanctioning fee for a Pre-Qualifying Tournament is \$50.00. Tournament sites and dates will be reviewed by your District Commissioner, Umpire-in-Chief and approved by the Nor Cal JO Commissioner or their designee. Contact your District Commissioner to find out the scheduled meeting date to review tournament requests in your area for the 2012 Season.

**Pre-Qualifying Tournament Directors must submit the results by way of "Order of Finish" and Completed Bracket (with scores) to the JO Commissioner and District Commissioner within 24 hours of completion of tournament.  
All results will be reviewed by the JO Classification Committee.**

Please make sure that you complete one request form for each Tournament that you want to host. Once completing the Tournament Request Form you will need to submit it to your **District Commissioner for approval**. (See second page for your District Commissioner). Your District Commissioner will review with the District UIC and if approved will submit your request to the Nor Cal JO Commissioner for final approval. Upon approval you will be mailed the Tournament Sanctioning Form. This form will need to be completed and return to the Nor Cal Office with the appropriate fee. The fee is \$50.00 for a Pre-Qualifying Tournament and \$25.00 for an Invitational Sanction Tournament with the check, payable to **Nor-Cal ASA** and mailed to P. O. Box 2829, Fair Oaks, CA 95628. These Tournaments will be listed on the 2012 Pacific Coast Region 14 Web-site (www.region14.com) and Nor-Cal ASA Web-site (www.norcalasa.org).
